Remarks: The 3% guaranteed convertible bonds due 2025 in an aggregate principal amount of US\$175,000,000 (the "Convertible Bonds") were issued in 2019.

On 5 December 2022, PB Issuer (No.5) Limited (stock code: 40097), being the issuer, repurchased US\$2,750,000 of the Convertible Bonds from its existing bondholders (the "Repurchased Convertible Bonds"), representing 13,220,414 shares if the Repurchased Convertible Bonds are fully converted into shares at the conversion price of HK\$1.63 per share. None of the Repurchased Convertible Bonds were converted into actual shares. Upon completion of the repurchase, the principal amount of the outstanding Convertible Bonds was US\$52,510,000.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
