Remarks: The 3% guaranteed convertible bonds due 2025 in an aggregate principal amount of US\$175 million (the "Convertible Bonds") were issued in 2019.

On 28 November 2022, PB Issuer (No.5) Limited (stock code: 40097), being the issuer, repurchased US\$9 million of the Convertible Bonds from its existing bondholders (the "First Batch of Repurchased Convertible Bonds"), representing 43,266,809 shares if the First Batch of Repurchased Convertible Bonds are fully converted into shares at the conversion price of HK\$1.63 per share. None of the First Batch of Repurchased Convertible Bonds were converted into actual shares. Upon completion of the repurchase, the principal amount of the outstanding Convertible Bonds was US\$59,081,000. The First Batch of Repurchased Convertible Bonds were subsequently cancelled on 30 November 2022.

On 29 November 2022, the issuer repurchased US\$0.5 million of the Convertible Bonds from its existing bondholders (the "Second Batch of Repurchased Convertible Bonds"), representing 2,403,711 shares if the Second Batch of Repurchased Convertible Bonds are fully converted into shares at the conversion price of HK\$1.63 per share. None of the Second Batch of Repurchased Convertible Bonds were converted into actual shares. Upon completion of the repurchase, the principal amount of the outstanding Convertible Bonds was US\$58,581,000.

On 30 November 2022, the issuer further repurchased US\$3,321,000 of the Convertible Bonds from its existing bondholders (the "Third Batch of Repurchased Convertible Bonds"), representing 15,965,452 shares if the Third Batch of Repurchased Convertible Bonds are fully converted into shares at the conversion price of HK\$1.63 per share. As at the date of the repurchase, none of the Third Batch of Repurchased Convertible Bonds were converted into actual shares. Upon completion of the repurchase, the principal amount of the outstanding Convertible Bonds will be US\$55,260,000.

- (viii) the trust deed/deed poll relating to the debenture, loan stock, notes or bonds has been completed and executed, and particulars thereof, if so required by law, have been filed with the Registrar of Companies.

Notes to Section I:

- *“issued shares as a % of existing number of shares before relevant share issue” should be construed as “redeemed shares as a % of existing number of shares before relevant share redemption”; and*
- *“issue price per share” should be construed as “redemption price per share”.*

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
